- Effective date for implementation of above-mentioned tariff for import containers will be BL issue date & for export shipments will be the booking date, effective from 06 NOV 2021 corresponding to 15 ABAN 1400.
- Date of complete discharge from vessel is the start date for calculation of demurrage/detention for import containers.
- Import container demurrage/detention will be calculated until date of return of seaworthy empty container to nominated empty depot as per container interchange.
- Export container demurrage/detention will be calculated on the basis of empty container pick up date from empty depot.
- Export container demurrage/detention will be calculated until date of submission of custom export documents & bill of lading issue & shipping instructions to shipping agent.
- Balance of cash deposit should pay to owner during 5 working days, in case of delay in settlement of detention & damage dues, after 2 notices with 5 days interval the deposit cheque may be presented to the bank for collection.
- Calculating demurrage charges for import cntrs will <u>start from Completed discharge</u> container from vessel.
- Calculating demurrage charge for export cntrs will <u>end on date of submission of export</u> <u>documents & shipping instruction</u> to shipping line.
- Cntr for special cargos such as Iso-tank & Bitutainer shall follow special agreement & is excluded of this tariff.
- The cnee/s can use Insurance facility in lieu of cash or cheque deposit.
- Above mentioned tariff is the standard tariff, no shipping company or agnet can apply a higher tariff than stated in above charts.
- In case of in dispute or disagreements, shipping association of Iran arbitration will be the sole arbitrator of all disputes and disagreements.
