Remarks

1. Issuing D/O at any branches other than head office (Tehran) shall be subject to 50% in D/O Fee.
2. 3% of THC will be collected as THC Commission for covering rate of exchange between the day shipment arrives and the day D/O is being collected (THC should being paid once VSL discharged) . 1% discount will be applied for forwarder companies & 2% will be collected.
3. USD 0.18/20' - Per Day & 0.27/40' – Per Day, will be collected in case of delay in payment and settlement of THC. Starting date of penalty charge is day of 26th after arrival of cntr.
4. THC for out of gag containers shall be 120% of the rate of regular containers. The use of wire, chain and similar devices for loading and discharge of container shall be subject to \$ 51 increase in THC.
5. Dangerous good containers must be declared to Port Authority by the Shipping Line 6 hours prior to arrival into Shahid Rajaei Port and 24 hours before arrival into other ports in writing.

Failing to do this or failing to comply with the respective standards in stowing and packaging of dangerous goods, an amount of 5000 USD for 20-ft container and 10000 USD for 40-ft container will be charged in addition to THC to be paid by the Shipping Line or his agent.

6. THC for bundled FLAT RACK Containers is USD 40.00/ 20' & USD 60.00/40'.
7. Transshipment Free Days 10 days
